Pastoral Training Institute Scholarships



#### The Need

Uganda has one of the world's fastest growing Christian populations in the world. Yet the low percentage of men in churches and the growing national orphan-crisis paints a very different picture. Churches are struggling to impact their communities. Pastors lack Biblical & theological grounding. The prosperity-gospel is widespread. Village pastors minister with little or no Biblical instruction and minimal support from other churches.

We believe that the answer to the orphan-crisis in Uganda and around the world is grounded in the local church. New Hope Uganda began its Pastoral Training Institute (PTI) to train and equip rural pastors in the Word of God for them to be effective in ministry, both in their churches and communities. Pastors are also trained in family-based agri-business as a means of provision for their families and a way to impact others.

PTI training takes place one week a month at our fifteen-acre farm, which serves as a macro-farm for training and instructing pastors while also providing sustainable income for running the course. While the income generated from the farm and its various projects (poultry, eggs, & pigs), as well as monthly contributions from the pastors themselves, help to offset basic running costs, it falls short of meeting our needs for the overall cost of the training.
